Uploading ID and Sharecode for a New IBA on Genistar Online

1. Once the Share Code has been generated, you will need to take a screenshot or photo of the sharecode information page, please see an example we created below.

Please check the written information to take note of the expiry date because this will be needed on their application; 3 September 2025.



You will notice that some sharecodes do not have an expiry date, such as the one below. In this instance the person has the **right to work indefinitely**, so on Genistar online please select the 'applicable' toggle next to Visa Expiration Date so it says 'No'.

2. You will then proceed to the next page, which will show the right to work share code. Please note, the right to work share code begins with a 'W'. Any sharecode not starting with a W will not be accepted.
